

## Syncona Limited – Article 23 Disclosures

28 June 2023

Syncona Limited (the “Company”) is an externally managed non-UK alternative investment fund for the purposes of the Alternative Investment Fund Managers Directive (2011/61/EU), as applicable in the UK (“UK AIFMD”).

Syncona Investment Management Limited (the “Investment Manager”) is the investment manager of the Company and its UK alternative investment fund manager for the purposes of UK AIFMD. The Investment Manager does not manage any other AIFs.

This document sets out the information required by Article 23(1) of the Directive and FUND 3.2.2R of the FCA’s Investment Funds Sourcebook to be made available to investors before they invest in the Company. The majority of the disclosures are by reference to our Annual Report and Accounts 2023 (Annual Report), which is the principal document through which the required disclosures are made.

Legal implications of the form of investment	<p>The Company is incorporated in Guernsey as a non-cellular company limited by shares, pursuant to the Guernsey Companies Law 2008 (as amended).</p> <p>Shareholders are bound by the provisions of the Company's Articles of Incorporation and the Companies Law. A copy of the Company's Articles of Incorporation can be found on the Company's website <a href="http://www.synconaltd.com">www.synconaltd.com</a>.</p> <p>The method of enforcing any judgments against the Company would depend on the nature of the judgment or order and the jurisdiction in which it originated. Under Guernsey law certain overseas judgements may be recognised and enforced (either by right or under the inherent jurisdiction of the Guernsey courts) without reconsidering the merits of the judgement.</p>
Identity of the AIFM, a description of its duties and investors' rights	The Investment Manager, Syncona Investment Management Limited. Its duties are to act as the Company's and other group entities' investment manager and to manage the investment of their assets. Investors do not have a direct cause of action against the Investment Manager.
Identity of the Company's depositary, a description of its duties and investors' rights	Citco Custody (UK) Limited. The duties of the depositary are asset safekeeping, general oversight and transaction processing. Citco Custody (UK) Limited also acts as custodian for a portion of the relevant assets. Investors do not have a direct cause of action against the depositary and custodian.
Identity of the auditor, a description of its duties and investors' rights	Deloitte LLP Guernsey. Its duties are to provide audit services to the Company, principally in relation to the audit of the annual accounts and independent review of the interim results. Investors do not have a direct cause of action against the auditors.
Identity of other service providers, a description of their duties and investors' rights	<p>Key service providers are set out on page 141 of the Annual Report:</p> <p>Citco Fund Services (Guernsey) Limited acts as company secretary and administrator.</p> <p>Goldman Sachs and Numis Securities act as brokers.</p> <p>In addition, The Northern Trust Company has been appointed as a second custodian, to custody relevant assets where management has been delegated to Kempen Capital Management (UK) Limited.</p> <p>Investors do not have a direct cause of action against any of the other service providers.</p>
Compliance with requirements in relation to professional liability risks	The Investment Manager covers professional liability risks through additional own funds at least equal to 0.01% of the value of the Company's investment portfolio.

Delegated management function by the AIFM, identity of the delegate and any conflicts of interest that may arise	The Investment Manager has delegated management of a portion of the Company's capital pool to Kempen Capital Management (UK) Limited. Fees, charges and expenses borne by investors	Shareholders in the Company do not directly incur fees, charges and expenses as a result of their shareholding. The Company and its group incurs operating costs associated with its investment and corporate activities. These costs are set out on page 120 of the Annual Report.  In addition, further details of the amounts payable to the Investment Manager are set out on page 96 of the Annual Report.
Fair treatment of investors	In accordance with the Listing Rules, the Company is required to treat all holders of the same class of its listed equity shares that are in the same proportion equally in respect of the rights attaching to such listed equity shares.
Preferential treatment received by any investor	The Company has entered into a relationship agreement with Wellcome Ventures, which owns 27.8% of the Company's issued shares. The agreement entitles Wellcome Ventures to appoint two or one directors (for as long as it holds at least 25% or 10%, respectively, of the Company's issued share capital) and provides certain rights to information, together with other provisions. Further details of the agreement were set out in the circular to the Company's shareholders dated 28 November 2016, a copy of which can be found on the Company's website <a href="http://www.synconaltd.com">www.synconaltd.com</a> . To date Wellcome Ventures has not exercised its appointment rights.
Procedures for issue of shares	Any issue of shares by the Company would be subject to, among other things, the Company's Articles of Incorporation, the Listing Rules and the Guernsey Companies Law 2008.
